- **President's Report.** Received Planning notice regarding change of zoning at 340 Michigan St. This change is to be from Single family residential to multi-family. Hearing is set for March 27, 2024 at 7:30 pm.
- **LAN Report.** Meeting is next week. See below.
- **Community Children's Center.** Will Averill, Director of Communications at the Children's Center and Pinkney resident gave an update on the opening at the new location. The opening is targeted for Fall 2024. The opening has been somewhat delayed due to funding issues (\$650,000 still needed). The center will utilize the entire building on 4th and Maine. The eastside will house the children's center and the west will have wrap-around services for family and kids. There will be a free indoor play area for kids up to 5 years. Plans are for a family resource center, clothing closet for children and expectant mothers. The center plans to partner with Just Food to provide ready-made and shield stable food items. An additional offering for the community is event/meeting space that can be utilized.

- **Neighborhood Signage.**
 - A Go Fund ME site was established by S. Heiman. A goal of \$600 is set and as of meeting time \$\$\$\$ had been contributed.

- P Englehart reported that messages were left with the Lawrence Public Library, Departments of Communication, Humanities regarding the posting of the job notice PEaslee Tech and KU's Career Center offered options for posting. Englehart will follow up.
